

Established in 1966 by the SUNY Board of Trustees and the New York State Board of Regents, "Upper Division College at Herkimer-Rome-Utica" began offering graduate education classes to graduate students using classrooms at West Frankfort Elementary School in the 1969 fall semester. Some 300 students enrolled in the first available programs: a Master of Science degree in Education, and teacher and administrator certificates.

[After a] regional political debate and expert analysis of several proposed sites, SUNY Trustees approved the selection of a site for the permanent campus at a meeting on October 31, 1969. The choice was Marcy. At Upper Division's temporary home in West Frankfort, plans were underway for something new: the first classes for transfer students were planned for the 1970 spring semester. Courses would be offered in "engineering science, accounting, social studies, and English." Area teachers working on a master's degree through SUNY Cortland's offerings still made up the majority of the student body.

Moving to the mills

With the addition of undergraduate transfer students, and growing demand from area teachers for graduate courses, the need for more space became evident. Anticipating continued growth, Upper Division moved in May 1971 to a new "temporary" location that would help sustain the institution and educate thousands of students for more than a decade. The college agreed to a three-and-a-half-year lease of the former Globe Mill Factory at 811 Court Street, in West Utica. With 20,000 square feet, Upper Division had space for a library, seven classrooms each seating at least 30 students, 18 faculty offices, administrative offices, and room to grow. The first classes in the new location were offered in a 1971 summer session. From 300 students in 1969, enrollment had doubled, with some 600 students taking classes on Court Street and at Griffiss in the fall of 1971.

The first president

In November, Robert W. MacVittie, then president of SUNY Geneseo, was appointed the first president of SUNY's new college. He told the *Observer-Dispatch* he hoped to "develop a long range plan to work on the college." But six weeks into MacVittie's presidency, New York State's looming fiscal crisis prompted SUNY Trustees to consider freezing or abandoning construction; they settled on a year's delay. MacVittie made plans to hire faculty and

staff, and expand operations at the temporary Globe Mill site. SUNY, meanwhile, considered a system-wide plan for zero growth that included cuts elsewhere and the closure of Upper Division. MacVittie said closing was only one option under consideration, and that he was still optimistic.

The New Year arrived, and with it came another blow: a huge cut in Upper Division's funding in Governor Rockefeller's proposed budget. Without legislative intervention, the college would get 72 percent less in operating funds in 1972-73 than it had received in 1971-72, \$175,000 compared to \$624,000. MacVittie made plans to depart after just two-and-a-half months on the job. With planning and funding for the new college apparently stalled, he resigned and returned to Geneseo. By the time the state budget was approved in May, SUNY had secured an additional \$400,000, giving the college \$575,000 - enough money to operate for another year.

NYS Senator James H. Donovan urged SUNY trustees to appoint a new president, and to restart stalled site work on the Marcy property. SUNY trustees voted to change the college's name, from Upper Division College at Herkimer-Utica-Rome to the "State University College at Utica-Rome."

A new president

"The history of 'Upper Division' has been up and down until this

year," Observer-Dispatch reporter Mike Woods wrote in February 1973. After some difficult formative years, and several setbacks, so much depended on the naming of a president who would believe in the college's unique mission – someone with the necessary combination of experience and commitment.

William R. Kunsela had been president of the State University Agricultural and Technical College at Delhi since 1955. With a doctorate in teacher education, he had served on the faculty of Cornell University's school of education for eight years, and had been a consultant to the United Nations, the World Bank, the government of Israel, and the Ford Foundation. As president of SUNY Delhi he had revitalized the college, developing its curriculum and the physical campus.

On February 28, 1973, SUNY trustees voted to appoint Kunsela president of the State University College at Utica-Rome. The first class of 58 undergraduates began attending classes in the fall; 50 of them were full-time students, and Jerome Donovan – Senator Donovan's son – was one of the 50.

In 1975, Governor Hugh L. Carey ordered a temporary freeze on construction. With the future campus still a question mark, on May 18, 1975, the college held its first Commencement, honoring 163 graduates at the Stanley Theater of the Performing Arts.

* * *

Another first in 1975: Genesis, the college yearbook, was published for the first time. The hundred-page volume documented a developing campus culture. The yearbook's inside front cover photo depicted the Globe Mill building; the inside back cover photo showed a scale model of the Marcy campus's first building.

* * *

In 1978, co-location and/or a merger with Utica College were explored, debated and rejected. Speaking the day after the November 1978 election, Utica Mayor Stephen Pawlinga said Carey's re-election "virtually assured" that the new campus would be built downtown. Citing the lack of funding for the downtown option – and likely opposition from SUNY – Senator Donovan disagreed: "I don't think the gov-

Street and "Potter Center," now home to the college's Division of Arts and Sciences, and the Division of Technology. The college also "completed rehabilitation of the Rome Center, formerly the Barringer School, used as an extension and conference center" in 1978.

Marcy campus approved

In April 1981, the Trustees acted. The Marcy campus was approved, but several programs were recommended to be "gradually withdrawn and transferred to other campuses," leaving the college to concentrate on mostly technology-related disciplines. Fewer students would be enrolled at the new campus than the college was used to; enrollment would not "exceed 1,400 full-time equivalent students," according

ernor is going to build a campus downtown." The college had already made a small move into the downtown area. After months of renovations, the former Potter School on Whitesboro Street was pressed into service in September with 11 classrooms, four laboratories and a gymnasium. Students, faculty and staff found themselves traveling between the Globe Mill building on Court

to the resolution. Despite the recommendations on mission and enrollment, supporters of the Marcy campus declared victory. Senator Donovan said it was one of his "proudest efforts." In June, the Senate approved a bill authorizing construction; in July, the Assembly followed suit. All that was needed was Governor Carey's signature.

On the same day a bill-signing ceremony was announced, Kunsela announced he would retire in 1982. On July 23, 1981, a few days after Kunsela's announcement, Governor Carey signed the bill releasing construction funds for the Marcy campus. Hundreds watched the outdoor ceremony in front of downtown Utica's State Office Building.

Hundreds attended the longawaited ceremonial groundbreaking on October 30, 1981, on a portion of the site near Flanagan Road. Because of uncertain weather, a huge tent had been set up for the occasion. "The question was not whether there should be a college but how much we could afford to invest in it," SUNY Board of Trustees Chairman Donald Blinken told those at the event. "I predict that in the long run the State University Board of Trustees will consider this one of our proudest and most successful achievements."

A new president

With the campus now under construction, the summer of 1982 saw a leadership transition that would shape the institution over its next two decades. Kunsela was succeeded by Peter J. Cayan, who had been president of North Country Community College in Saranac Lake, N.Y., for six years. The first 13 years of his academic career had been spent at SUNY Delhi, where he was a member of the faculty and later dean in the school of business management; Kunsela was president of SUNY Delhi for most of Cayan's time there. "Bill was always excited when he talked about this college," Cayan said later. "That was a very encouraging thing when I looked at coming here. I think Bill's enthusiasm helped the college." The SUNY Board of Trustees confirmed Cayan's appointment as president on May 26, 1982, and Kunsela's retirement took effect August 1.

The campus dedication

Awaited for so long by so many, the 1985 dedication of the new campus would be no simple affair. A week's worth of events was planned. The official schedule included a press conference in the Administration-Library-Classroom (ALC) Building kicking off dedication week with the reading of proclamations; a two-day telecommunications conference ("for top-level managers and administrators from business and education") at Utica's Sheraton Inn and Conference Center "where speakers and panel members will discuss 'Acquiring a Communications System;" the dedication of the Gannett Art Gallery, the opening of its first juried show, and an awards ceremony; performances by SUNY Jazz and the SUNY College at Purchase Woodwind ensemble; and, on Friday, November 8, the campus dedication ceremony and laying of the ALC cornerstone. In the middle of the dedication ceremony, the crowd responded with a standing ovation to the announcement that the ALC building would eventually be named William R. Kunsela Hall in honor of the former president.

"[W]hat really made the difference," said SUNY Trustees Chairman Blinken, "was the overwhelming desire on the part of the greater Utica-Rome, Oneida County community to have a first-class, modern facility that could effectively serve not only this region, but all the people of New York State."

Annual Awards Include Special 40th Anniversary Recognition

The 2006 Alumni Association/Hall of Fame Awards Event, held Sept. 30 at SUNYIT, included traditional awards, a new fac-

ulty award, and a special presentation as part of the college's 40th anniversary celebration.

The Alumni Association's top honor, the Outstanding Alumni Achievement Award, was presented to Doug Robinson '88 (M.S., Business Management), of New Hartford, N.Y., who is Chairman of the Board and Chief Executive Officer of the companies

of the Utica National Insurance Group, one of the top 100 property and casualty insurance organizations in the country and among the largest headquartered in New York State, with more than \$2 billion in assets.

The Outstanding Alumni Achievement Award, the

As Utica National's CEO, Robinson has led the company to some of its best operating results ever, with Utica National's Policyholders' Security Fund growing to a record level over the last three years. These results followed one of the darkest times that Utica National and the property-casualty insurance industry had ever seen, with claims in 2001 from the 9-11 terrorist attack being part of a "perfect storm" that severely affected the industry, which also included the effects of adverse development on existing claims and severely inadequate rates from years of intense competition.

The Distinguished Service Award recognizing service to profession, community, and/or SUNYIT was presented to Mary **Kay Driscoll '95** (B.S., Health Information Management), of Peckville, Penn., and **Mike Dumas '85** (B.T., Electrical Engineering Technology), of Manlius, N.Y.

Driscoll directed the effort that established the current SUNYIT colors, and served as URSA Secretary and Junior Senator, College Council student representative, Cheerleading Captain, Orientation Leader, Residence Hall Council member, and SHIMA member. Her professional accomplishments include writing a training prototype with the Department of Energy for responding to chemical/nuclear/ biological terrorist attacks that was implemented into its national operations center, authoring six professional journals in national Health Information Management journals and trade publications, and designing national medical office curriculums.

Dumas served as URSA Senator, College Council student representative, member of the College Association board of directors, President of the Student Activities Board, and was the student-elected Commencement speaker. Since leaving SUNYIT, he has had an exciting and fulfilling career in both the commercial and Department of Defense engineering fields. His accomplishments include managing the development of sales force automation and information security applications for Xerox that are now utilized daily by thousands of sales representatives handling more than 6 million customer establishments.

The Outstanding Young Alumni Award recipient was **Stacey Bryden '02**, (B.S., Computer/Information Science), of Herndon, Va.

Bryden has worked steadily in systems-security positions since her SUNYIT graduation, while earning a master's degree in Network Security and pursuing a doctoral degree in Business Administration with a concentration in Computer and Information Security. She joined Lunarline Inc. in Washington, D.C., as Senior Security Analyst/Contractor Special Security Officer (CSSO) and since May 2006 has simultaneously served as Project Manager for the Institute for Security and Open Methodologies in Washington, D.C., co-managing the project for the Computer Forensics Open Source Methodology.

Commemorating the vital contributions of SUNYIT's student leaders during its historic first 40 years, a special one-time Alumni Association URSA-SA Presidential Pioneer Award was presented to honor all SUNYIT student-government presidents from its founding to 2006: **Thomas William Libous '75**, **William John Ryan '76**, **Joseph J. 
Three dedication ceremonies were held in summer 2006 to celebrate the naming of rooms in the Cayan Library and the establishment of scholarships.

Four New Graduate Nursing Offerings

Two Master's Programs, Two Advanced Certificates Start This Academic Year

The School of Nursing & Health Systems is launching two master of science degree programs and two certificate of advanced study programs in 2006-2007: master's degrees and advanced certificates in nursing education and gerontological nurse practitioner.

"I am pleased to announce the addition of these programs, which will give nurses and prospective nursing students additional opportunities for career advancement," said **Peter A. Spina**, president. "The addition of nursing education and gerontological nurse practitioner programs will help to address issues of concern in the Mohawk Valley and our region stemming from the continuing nursing shortage, and the growing health care needs of our aging population."

According to the American Association of Colleges of Nursing (AACN) a nationwide shortage of faculty in schools of nursing

with baccalaureate and graduate programs is a growing problem adding to the national crisis in the nursing shortage; many schools of nursing are limiting the number of students admitted to their nursing programs. Government and academic researchers also report 20 percent of Americans will be 65 or older by 2030, which will fuel an already substantial need for gerontological nurse practitioners.

"The master of science degrees in nursing education and gerontological nurse practitioner programs will have a positive impact on the preparation of nurses for faculty roles in nursing education and specialty roles in gerontology nursing," said **Esther Bankert**, Dean of the School of Nursing & Health Systems. "The postmaster's certificates in advanced study in both programs are also available for graduates of a master's degree program in nursing. Each

of these new programs will have a significant contribution to our profession and our community; they will produce highly qualified nurse educators for future faculty positions and advanced practice nurses to enhance the quality of life of our senior populations."

In addition to the newly announced programs, SUNYIT offers a bachelor of science degree in nursing for RN students; a bachelor of science degree in health information management; and master of science degrees in nursing with majors in nursing administration, adult nurse practitioner and family nurse practitioner. An accelerated RN to BS/MS programs allows practicing nurses to complete both bachelor's and master's degrees in nursing within three years of full-time study. Advanced certificates are also offered in adult and family nurse practitioner, and nursing administration.

Two New Buildings Planned

Field House, Student Services Building on Drawing Board

Planning for two major campus projects got underway during SUNYIT's 40th anniversary celebration. In the spring, state lawmakers supported \$20 million for an athletic field house on the SUNYIT campus to the 2006-2007 state budget.

"This is an important step forward for the campus and the community," said SUNYIT President **Peter A. Spina**. "We are grateful to Assemblywoman **RoAnn Destito** and Senator **Raymond Meier** for their strong support of this project, and we also thank our area's other elected officials, chambers of commerce, community leaders and

individuals – all of whom voiced support for what will be a valuable campus and community asset."

Destito and Meier have said the field house would support the development of the campus, drawing area residents to SUNYIT and providing surrounding communities with a much-needed regional recreation facility. In May, they met with dozens of area officials from towns, villages and school districts to discuss how the field house could best meet the needs of area residents. An advisory group of area officials was formed to provide input as plans for the building take shape.

The field house is the second new building funded by the legislature in the last year. Planning was already underway for a \$13.6 million student services building funded in last year's state budget. The student center will provide a state of the art facility, be an important front door to the campus and complete a much needed quadrangle. Groundbreaking for both projects is expected to occur in 2007.



Three Inducted Into Wildcat Hall of Fame

Three former SUNYIT studentathletes were inducted into the Wildcat Hall of Fame during Fall Fest. Toni Darling Johnston, Sarah Schiavone Lidbom, and Mark Sierak were honored at a September 30 awards ceremony.

Toni Darling Johnston '99

During her two-year softball career at SUNYIT, Toni pitched all 32 victories for the Wildcats and as a senior led SUNYIT to its best record (19-16) to date. She was named to the All-SUNYAC softball team in each of her two seasons and as a junior threw for 13 wins, scored 31 runs and batted .400. As a senior, Toni batted .374 and led the team with 32 RBI and 58 stolen bases while pitching every inning of all 19 wins in the Wildcats first winning season of SUNYAC play. 
