#### BYLAWS Article III-Board of Directors

Section 3.3. Number and Qualifications: All Directors shall be at least eighteen (18) years of age. As used in these by-laws, the term "entire Board" means the total number of directors entitled to vote which the Corporation would have if there were no vacant director positions. No decrease in the number of Directors will shorten the term of any incumbent Directors. The Board shall be composed of Directors from each of the following constituencies representing the students, alumni/local community, faculty and officers of the administration of the University, the size of the Board and exact number of directors from each constituency to be determined by the Board from time to time, provided that the Student Directors must always comprise not less than one-third (1/3) and not more than one-half (1/2) of the Board. Until further action of the Board the size of the Board shall be 15 Directors, comprised as follows: six (6) Student Directors, three (3) Administrative Directors, two (2) Faculty Directors and four (4) Community Directors of which at least one will be an alum of the college.
